Scarsdale Welcomes New Firefighters and Police Officers

"At the Fire Department Ceremony on Monday, September 8, we officially welcomed firefighter Nicholas Camardella. Later in the day, we welcomed new Police Officers Philip Del Bene, Coleman Murphy and Manuel Vega," said Scarsdale Mayor Justin K. Arest at the September 9 Village Board of Trustees meeting. Patrol Sergeant Patricia Arcesi was promoted to Lieutenant, the first female Lieutenant in the Department.

Victoria Sirota was reappointed to serve a six-year term as Town Assessor and Toby Levin was appointed to the Town Board of Assessment Review. Melissa Chai was appointed to the Arts Advisory Council.

Mayor Arest opened the meeting by recounting many important September events.

"We began the month with Labor Day, reminding us that work is more

than a job title," Arest stated. "It is the daily effort of residents, staff and neighbors who make Scarsdale what it is. Thursday, September 11 is Patriot Day. We pause to remember the lives taken, the families forever changed and first responders who ran toward danger. Let us honor them with silence, reflection and kindness. Mayor Justin K. Arest

"September is also

National Preparedness Month. Make a family plan, check flashlights, medications and sign up for emergency alerts. We can never be too prepared

and if an emergency occurs, readiness matters.

"We mark Suicide Prevention

Month, a chance to end stigma around mental health. The 988 Suicide and Crisis Lifeline Number is always available. From September 15 to October 15 we celebrate Hispanic Heritage Month. Rosh Hashanah begins at sundown on Monday, September 22 and Yom Kippur, Wednesday, October 1."

Although the Public Hearing for Proposed

Local Law to Amend Chapter 281 of Scarsdale Village Code concerning licensure of commercial tree businesses was adjourned to September

30, concern was expressed regarding the cutting rate of Village trees—for every 1.000 trees cut down only 300 are replaced.

The Village also renewed a lease agreement with AT&T to place wireless telecommunication facilities on the smokestack at 110 Secor Road. Trustees also agreed to hold a Public Hearing on September 30 for a code change that will extend metered parking until midnight. It is now prohibited to park in metered spaces after 11 PM.

In a work session before the meeting, Scarsdale Police Chief Steven DelBene requested funding for a new dispatch and record keeping system. The new system would cost \$126,000 in the first year and \$72,000 in the second year, and would allow police to respond to emergency calls more quickly.



Smoke Testing in the Bronx River Sewer District

The Village of Scarsdale's consultant Mott MacDonald (MM) conducted smoke testing of the sanitary sewer lines and service connections to determine locations where excess rainwater and groundwater, also known as inflow and infiltration (I&I), may be entering the sewer system. The Village has a regulatory obligation to identify and ensure remediation of any public or private infrastructure contributing to I&I.

The testing area included portions of Overhill, Bramlee Heights, Arthur Manor, Drake Edgewood, Old Scarsdale, Heathcote, Sherbrooke Park, Murray Hill Middle Heathcote, and Fox Meadow neighborhoods. Smoke testing occurs on a street-by-street basis with direct notification to each property owner in the testing area. During testing, a non-toxic and non-staining smoke is released into manholes, which travels through the sanitary sewer system to detect breaks, leaks, and other deficiencies. During testing, smoke may be observed discharging from a variety of sources, including roof vents, building foundations, the ground, and catch basins.

Smoke will not enter a home under most circumstances, but smoke may enter a home if any of the following plumbing deficiencies are present:

Vents connected to a home's sewer pipes are inadequate, defective, or improperly installed:

Traps under sinks, tubs, basins, showers, or other drains are dry, defective, improperly installed, or missing; or

Pipes, connections, and/or wastewater drain system seals are damaged, defective, improperly installed, or have plugs missing.

Smoke entering a home is likely an indication that the underlying plumbing problem has also likely been allowing sanitary sewer gases and odors to enter the home, potentially contributing to unpleasant odors. Therefore, smoke testing not only helps the Village to identify and remediate problems with the Village's sewer infrastructure but may also help homeowners by identifying private plumbing system problems requiring attention.



Westchester County Invests in Parents, Career Training and Crime-Fighting Technology

The Westchester County Board of Legislators acted to improve life quality for families, passing legislation to ensure diaper changing stations are available to all parents. Westchester families will soon find diaper changing stations in more places, easing outings with young children for mothers, fathers and other caretakers. The Board passed new bipartisan legislation requiring at least one changing station in all County park bathrooms and on each publicly accessible floor of County buildings. Currently, many men's restrooms lack these facilities, forcing fathers to seek alternatives or ask female family members to handle diaper changes.

The bipartisan DIAPRS Act (Diapers Involve All Parents Regardless of Sex) was co-sponsored by 13 legislators from both parties. The County's Department of Public Works and Transportation will create a plan indicating where new stations will be installed, their cost, and installation timeline.

Legislator Erika L. Pierce said, "Being able to change a diaper on the fly is no small need, and this legislation will help us make certain that every caregiver, regardless of their gender, can do that safely and hygienically. This is a real win for dads all across Westchester."

Westchester Community College, part of the State University of New York (SUNY) system, now has approval to relocate the SUNY Westchester Educational Opportunity Center (EOC) to a larger, modern facility, following the Board's passage of its 11-year lease. The new 44,000-square-foot facility on four

floors in Building #3 at 28 Wells Avenue in Yonkers will significantly expand the center's capacity.

The EOC's tuition-free programs provide crucial pathways for adult students to improve their financial trajectories and those of their families. The center offers vocational training programs, college preparation courses, and workforce development services that help eligible adults gain the skills and credentials needed for higher education or career-focused employment.

Legislator Jewel Williams Johnson, Chair of the Board's Budget and Appropriations Committee, said, "As Legislator for District 8, home to WCC's main campus and the district with the most students enrolled, I am proud to support this Local Law securing a new, stable home for the Educational Opportunity Center. Though the site is in Yonkers, this modern facility is an investment in our entire County. By expanding space and resources, we're opening doors for more residents to gain the skills needed to thrive. This is not just about buildings — it's about strengthening lives, families, and communities. Education remains our surest pathway to equity, mobility, and prosperity."


In other business, Westchester residents will benefit from faster, more thorough investigations thanks to new funding for the District Attorney's Office. The County Board approved \$1,091,000 to purchase modern crime-fighting tools. The funding will pay for improved forensic equipment to analyze evidence, upgraded surveillance systems to track criminal activity, and new computers and software to help prosecutors build stronger cases.

Newcomers: Plans gatherings for new residents in Edgemont to get to know each other and the greater community.

Programming: Plans and assists with community-wide events to bring residents together and foster community spirit and belonging.

Public Safety: Advocates for public safety initiatives to improve the quality of life in Edgemont, including initiatives related to traffic, sidewalks, and pedestrian safety.

This year, the ECC will also be establishing a Special Committee on Environmental Education, which aims to educate Edgemont residents about environmental issues and local initiatives while promoting a sustainable lifestyle — such as reducing food waste, planting native plants/removing invasive plants, and adopting eco-friendly lawn care.

Each committee meets regularly, with varying schedules. The ECC Board of Directors meets monthly — typically the first Monday of each month from September through June — in the Edgemont High School Faculty Lounge. All Edgemont residents are welcome to attend.


Radical Sisters: Shirley Temple Black, Rose Kushner, Evelyn Lauder, and the Dawn of the Breast Cancer Movement, by Judith L. Pearson

Written by award-winning biographer Judith L. Pearson, Radical Sisters: Shirley Temple Black, Rose Kushner, Evelyn Lauder, and the Dawn of the Breast Cancer Movement is the rich and meticulously researched narrative of three women who couldn't have been more different, until they were diagnosed with breast cancer. In an era of medical myths and antiquated protocols, their intertwined sto-

ries began with the realization that treatment choices might not be their own.

In Radical Sisters, Pearson skillfully transports readers through three decades of a changing social landscape in America (the 1970s through the 1990s), highlighting the courage that transformed society's approach to breast cancer. Independently, these pioneers took on the most prevalent issues of their time: the cause, treatment, awareness, and cure of the disease. While none of them set out to be the trail-blazing advocates they became, they did for themselves what the mainstream healthcare system refused to do.

When Shirley was diagnosed in 1972, she eschewed the current surgical protocol of biopsy and potential radical mastectomy



all in one step. She then took the daring step of becoming the first celebrity to publicize her cancer. After Rose's 1974 diagnosis, and against overwhelming odds, her self-proclaimed "streak of stubbornness and loud voice" eventually saw to the eradication of that outdated "one-step" procedure, along with the barbaric radical mastectomies. From her deathbed, she valiantly shepherded

legislation for insurance coverage of mammograms and breast reconstruction (which passed Congress just months after she died). Evelyn Lauder then picked up the battle when she was diagnosed with breast cancer in 1988. She was incensed by the lack of a comprehensive treatment center, paltry research funds, and lack of awareness for a disease that was literally killing women in epidemic proportions. Employing her impressive address book, she oversaw fundraising for New York City's Evelyn Lauder Breast Center and the Breast Cancer Research Foundation. And in a 1992 stroke of genius, she used her world-wide network of cosmetic counters to launch the now ubiquitous pink ribbon.

Scarsdale School Board Considers 2026 Bond Referendum

After nine meetings between March and September, the Capital Projects Steering Committee, a multi stakeholder group of roughly 40 members, recommended an initial scope of work to the Scarsdale Board of Education. The scope of work includes a proposed \$95.6 million in infrastructure, air conditioning, fields and building construction/renovation projects. The estimated annual average property tax increase would be about \$560.

The action marks the start of a months-long process of engagement around the recommendations and refinement of a work scope for a potential bond referendum in 2026. Opportunities for community input will be forthcoming. 



The Pros and Cons of Co-Fiduciaries in Estate Planning

In estate planning, a fiduciary is someone entrusted with managing another person's assets and affairs, often serving as an executor, trustee, or power of attorney. Many individuals consider appointing co-fiduciaries—two or more people sharing fiduciary responsibility—to ensure a balance of perspectives and safeguard decision-making. Many clients express a desire to treat all of their children equally, which often leads them to consider naming all of them as co-fiduciaries. While co-fiduciaries can offer several advantages, there are also important drawbacks to consider.

Pros of Appointing Co-Fiduciaries

Checks and Balances: One of the most common reasons for appointing co-fiduciaries is to create a system of checks and balances. When more than one person is involved, the risk of mismanagement, fraud, or favoritism is reduced. This can be particularly important in high-value estates.

Shared Workload: Estate or Trust administration can be time-consuming and complex. Co-fiduciaries can divide responsibilities, such as communicating with beneficiaries, managing assets, filing taxes, and handling legal matters. This shared workload can reduce stress and ensure that no single fiduciary is overwhelmed. Co-fiduciaries can also bring complementary skills to the table. For example, one fiduciary might be financially savvy, while the other has strong interpersonal skills for dealing with family dynamics. This can lead to more well-rounded decision-making.

Family Representation: In blended families or when children from multiple marriages are involved, appointing co-fiduciaries from different branches of the family can help maintain neutrality and foster trust among heirs.

Cons of Appointing Co-Fiduciaries

Risk of Disagreement: Co-fiduciaries must make decisions together, and disagreements can delay important actions or lead to legal disputes. If the co-fiduciaries have conflicting personalities or values, the process can become contentious, causing friction among heirs and potentially increasing legal costs. If the co-fiduciaries are family members, it can also lead to conflicts among family

members and strain or even damage relationships. While the intention may be fairness, asking children to manage an estate together can place emotional stress on them—especially during a time of grief. The pressure to make joint decisions under emotional strain can deepen rifts rather than promote unity.

Slower Decision-Making: Requiring the agreement of multiple parties often slows down decision-making, especially if the fiduciaries are located in different cities or states. In urgent situations, such delays can be problematic. If co-fiduciaries are evenly split on a decision and there's no mechanism in the estate plan to resolve a deadlock, administration can stall entirely. This might require court intervention to break the tie, further complicating the process.

Unequal Participation: In practice, one co-fiduciary may end up doing the bulk of the work while the other remains passive. This can breed resentment or lead to inefficiencies, particularly if compensation is shared equally.

Difficulty in Financial Institutions and Courts: Some banks, brokerage firms, or courts prefer working with a single decision-maker. They may impose stricter requirements when multiple fiduciaries are involved—such as needing all signatures for every transaction—leading to delays and frustration.

Conclusion

Appointing co-fiduciaries in an estate plan can provide balance, accountability, and shared responsibility—but it can also introduce the risk of conflict, inefficiency, and delays. When considering co-fiduciaries, it's important to choose individuals who communicate well, share mutual respect, and are capable of working together under pressure. Consulting with an estate planning attorney can help you weigh these factors and structure your fiduciary appointments to best serve your estate's goals.
